## INSTALLATION TIPS

Never use saddle valve for connection.

Use 3/8" water line.

Install vertically with cartridges hanging down.

Allow 2½" (6.35 cm) clearance below the cartridge for easy cartridge replacement.

Flush MicroGuard™ Pro 2 Cartridge by running water through filter for three (3) minutes at full flow.

## OPERATION TIPS

Change cartridges on a regular six (6) month preventative maintenance program.

Change cartridges when capacity is reached or when pressure falls below 10 psi (0.7 bar).

Service flow rate must not exceed 1 gpm (3.8 Lpm).

Always flush the filter cartridge at time of installation and cartridge change.

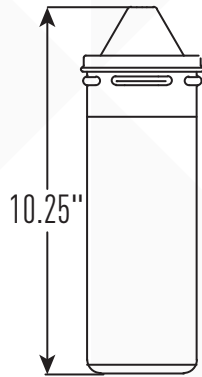
